With reference to above, I would like to inform you that Dr B. K. Sthapak, the first Chancellor of the OP Jindal University (OPJU) is completing his tenure as Chancellor on March 31, 2018. Therefore, for the appointment of next Chancellor, Jindal Education and Welfare Society (JEWS), the sponsoring body of the university has passed the resolution (copy attached) to appoint Mr. Naveen Jindal, noted Parliamentarian, Philanthropist, and Industrialist as Chancellor of OP Jindal University.

On extensive deliberations amongst the members of the sponsoring body JEWS, it was recommended that the appointment of Mr. Naveen Jindal, Chairman of JSPL Group companies as Chancellor of the OP Jindal University, Raigarh (C.G.) is in the best interest of building OP Jindal University into a world-class institution as envisioned from its inception. Mr. Naveen Jindal has contributed to nation building through many facets, as a former Lok Sabha MP, Industrialist, Philanthropist, Sports person, and Educationalist, will help to establish OPJU as a premier University within the state of Chhattisgarh.

However, article 2.1 of statute no.2 of the university stating that JEWS & the proposed Private University shall not appoint persons who are family members or from the company to the key posts of Chancellor and Vice Chancellor etc. and shall ensure the appointment of eminent academicians or industrialist on such posts. Hence, the visitor's office disagrees to accept our request without the appropriate amendment in the article 2.1 of statute no.2 of the university.

In order to make Shri Naveen Jindal as Chancellor for the betterment of the university, the Board of Management of the university has passed the resolution (Copy Attached) for appropriate amendment in the article 2.1 of the statute no.2 and recommended to Governing Body. The copy of the existing statute no. 2 is also attached for your kind reference.

The original matter of article 2.1 and proposed substitution is given in below table.

appointment of eminent academicians or industrialist for this post.

Provided that, for making the O P Jindal University, functional, their sponsoring body shall appoint the Chancellor in consultation with the State Government for a minimum period of one year but not exceeding three years.

The sponsoring body shall, by simple majority, finalize the name of the Chancellor. The President/Secretary of the sponsoring body shall send the name, along with bio-data of the proposed Chancellor, to the Visitor for approval".
